The seniority in respect of the Asst. Engineers/Electrical indicated in the Final Seniority List vide ref. 4th cited above against Serial Nos.328 to 473 has been reviewed and revised vide ref. 6th cited consequent to the representation of Smt. N. Pushkarini for rectification of her seniority as per the roster drawn for selection of Asst. Engineers/Electrical appointed by Direct Recruitment under the Notification of 2005.

2) In the said revised seniority list vide ref. 6th cited, the name of Smt. G. Leelavathi, AE/Elec at Serial No.425 who was within the ambit of Serial Nos.328 to 473 has been erroneously omitted. While rectifying the omission, it has been noticed that the selection of Smt. G. Leelavathi (DOB: 10-06-1969) (HH) was against the Roster Point No.6 (OC-PH-W) in the approved list dt.07-12-2005 drawn for Direct Recruitment of Asst. Engineers/Electrical under the Notification of 2005 which places Smt. G. Leelavathi above Sri D. Madhava Rao (DOB: 12-10-1980) appointed under Roster Point No.7 (SC). Sri D. Madhava Rao has stood at Serial No.328 in the seniority of Asst. Engineers/Electrical as indicated in the Final Seniority List dt.02-05-2011. Therefore, the seniority of Smt. G. Leelavathi in the Final Seniority List is required to be reviewed and revised placing her above Sri D. Madhava Rao (at serial no.328) since the ROSTER is the virtual basis for seniority.

3) After careful consideration, the seniority position of Smt. G. Leelavathi in the cadre of Asst. Engineer/Electrical appointed against Roster Point No.6 (OC-PH-W) under the NOTIFICATION of 2005 is now reviewed and revised in terms of Regulation 26(a) of APSE Board SRs Part-II as adopted. Smt. G. Leelavathi (DOB: 10-06-1969) appointed against Roster Point No.6 (OC-PH-W) in the approved list dt.07-12-2005 drawn for Direct Recruitment of Asst. Engineers/Electrical under the Notification of 2005 is now placed above Sri D. Madhava Rao at Serial No.328 as indicated in the Final Seniority List dt.02-05-2011.

4) The Assistant Engineers/Elec as indicated in the Annexure appended to Memo. 4th cited. are hereby directed to submit their objections, if any with supporting proof of claim to the Undersigned against the proposed revision of seniority in respect of Smt. G. Leelavathi placing her above Sri D. Madhava Rao who stood at serial no.328 as per

Final Seniority List dt.02-05-2011 within 15 days from the date of receipt of this Memo failing which it will be construed that they are not having any objections for the proposed action and further action will be taken as proposed in para-2 above.

5) The Concerned Controlling Officers are hereby directed to obtain a dated acknowledgement from the affected candidates as indicated in the COLUMN "REVISED SENIORITY LIST" in the Annexure appended to this Memo and send the receipt of acknowledgment to the Undersigned by return FAX and POST COPY for confirmation.
