ORDER :-

As per the Minutes of the 158th Board Meeting, modification of the existing Medical Policy communicated vide G.O.O.4th cited the following orders are issued in line with the APTRANSCO vide reference 6th cited, which shall come in to force with immediate effect.

GENERAL AILMENTS:

The amount of Rs. 2.00 Lakhs for life time for General ceiling is enhanced to Rs. 3.00 Lakhs.

SELF FUNDING MEDICAL SCHEME:

Existing ceiling of Rs. 3.00 lakhs under Self-Funding Scheme remains the same. The employees are allowed to avail the amount available under self funding scheme subject to availability of the funds and then shall avail the amount under general ceiling. EPF holders who ever contributes the fund after retirement they are eligible for the same.

MAJOR AILMENTS:

The existing amount of Rs. 6.00 lakhs for major ailments/surgeries/treatments i.e., CABGS, Double valve replacement, Kidney Transplantation, Cancer, Neuro Surgery, Aortic valve replacement, PTCA STENT be restricted to three spells for each of these diseases maximum ceiling limit of 2.00 lakhs per spell and Cancer/Chemotherapy/Radiation therapy, is enhanced to Rs. 8.00 lakhs in three spells i.e., 2.00 lakhs for 1st & 2nd spells and Rs. 4.00 lakhs for 3rd spell.

EYE TREATMENT:

The existing sanction of expenses for eye treatment for Rs. 14,000/- for 3 times of life time irrespective of category/cadre for all employees/pensioners is enhanced to Rs. 20,000/- for three times in life time.

MASTER HEALTH CHECK UP:

The existing ceiling limit for reimbursement to Master Health Checkup for Rs. 3,000/- (Rupees three thousand only) for each time i.e., 3 times in service in life time is enhanced to Rs. 4,000/- (Rupees four thousand only) for each time i.e., 3 times in life time. Master Health Check up now extended to all the pensioners in the Regcognised hospitals of APGENCO for 3 times including the availment while they were in service.

REIMBURSEMENT FOR DELIVERIES:

The APGENCO is hereby extended the benefits for reimbursement of medical charges incurred towards the deliveries of the spouse of male employees up to two living children as per package rates. Reimbursement of medical bills for the treatment taken in un-recognised hospitals, for reimbursement of deliveries on case to case basis shall be adhered to. However enhanced rate agreed above are not applicable for the treatment taken in un-recognised hospitals.

EXTENDING THE MEDICAL FACILITY TO THE RETIRIES COVERED UNDER EPF

The employees covered under EPF after their retirement be continued the same benefits on par with pensioners to the extent the APGENCO is providing the benefits as per G..O.O. 4th cited

HOSPITALS IN HYDERABAD:

The recognized hospitals in Hyderabad will be continued as referral hospitals for 10 years period as agreed in the State Re-Organization Act, 2014.
