ORDER:

In terms of the orders issued vide G.O.1st cited, an Amendment to the Regulation.16(a)(1) of APSEB Service Regulations Part-I, as adopted by APGENCO, has been issued enhancing the age of superannuation from 58 years to 60 years "with immediate effect" vide G.O.O.4th cited. Further, an addendum to the said Regulation.16(a)(1) of APSEB Service Regulations Part-I has been issued vide G.O.O. 9th cited, substituting the words "with effect from 02.06.14" in place of "with immediate effect" in terms of the orders issued vide G.O.O. 8th cited read with G.O. 5th cited.

2. As per the instructions issued vide memo 10th & 12th cited, the employees who were eligible for re-induction into service and remitted the pensionary benefits released to them, viz.(a) Commuted value of pension (b) Retirement Gratuity (c) Encashment of Earned Leave along with interest @ SBI MCLR+2.5% per annum till date of remittance, have been issued re-induction orders. In memo 13th cited, further instructions were issued relaxing certain conditions for re-induction of employees who retired at the age of superannuation @ 58 years and not completed 60 years of age. Accordingly, notices were issued to the eligible candidates vide memo 14th cited.

3. In response to the same, 3 Nos. Chief Engineers (Elec./Mechl.), 1 No.SE(Elect.), 1 No.DE(Mechl.), 8 Nos.ADEs(Elect./Mechl.), 3 Nos.AAEs(Elect./Mechl.) and 1 No. Sr.Chemist have remitted the Retirement Gratuity amount already paid to them and requested to issue re-induction orders. As there are no vacancies available in the cadre of Chief Engineer (Elec./Mechl.), Superintending Engineer(Elect.)/Divisional Engineer (Elec.), Assistant Divisional Engineer (Elec./Mechl.), the juniors in the said cadres shall require to be reverted to the cadre of Superintending Engineer(Elect.)/Divisional Engineer (Elec.)/Assistant Divisional Engineer (Elec./Mechl.) and Assistant Engineer/Additional Assistant Engineer (Elec./Mechl.).

4. After careful consideration, certain CEs/SEs/DEs/ADEs (Elec./Mechl.) mentioned in the Annexure appended to this order are hereby reverted to the lower cadres and posted to the places noted against each. However, upon reversion, their pay shall be re-fixed in the reverted cadre duly protecting the pay in the reverted cadre notionally.

5. The concerned controlling officers are requested to relieve them with immediate effect so as to enable them to assume charge accordingly at the place of posting ordered above.
