Order:

The Learned Advocate General of A.P. was requested to appear and defend the case W.P.No.17994 of 2015 filed by the APGENCO against the orders of Government of Telangana, unilaterally approving guidelines for final allocation of the employees based on nativity of employees as per Service Register and Writ Appeals filed by T.S. Genco before the Hon'ble High Court of judicature at Hyderabad for the State of Telangana and the State of A.P.

2) In the reference cited, Sri. Dammalapati Srinivas, Learned Advocate General of A.P. has requested to arrange to pay an amount of Rs.10,00,000/- (Rupees Ten lakhs only) towards his Professional Fee in the writ petition and Rs.3,00,000/- (Rupees three lakhs only) towards his Junior Counsel Sri D.Ramesh, Special Government Pleader for disposal of W.P.No.17994/15 filed by APGENCO against the orders passed in Lr.No.686/HR.A1/2015 dated 6-6-2015 issued by the Secretary to Govt. Energy Department/Telangana and consequential order issued by T.S.Genco vide T.G.O.O.No.92/CGM(ADM,IS&ERP)/2015, Dated 10-6-15.

3) The Bill/Letter dated 16-3-2018, received from the Learned Advocate General of A.P. is examined and found that he has filed the W.P.No.17994/15 and defended the cases on behalf of A.P.Genco satisfactorily for sanction of the above fee.

4) As per the delegation of Powers ordered in G.O.O.No.270/GM(Adm.,)2003, dtd.24.07.2003, the functional head in the rank of Chief Engineer/FA&CCA is competent to sanction the “Legal Fee and Expenses” as per approved scales as per which the Joint secretary (per.,) is Competent to sanction the above “Legal Fee” to Sri Dammalapati Srinivas, Learned Advocate General of A.P. and his junior Counsel Sri. D.Ramesh, Special Government Pleader.

5) After careful consideration, and in exercise of delegation of powers ordered in G.O.O.270/GMA(Adm)/2003 dated 24.07.2003 read with G.O.O.No.504/CS/2013 Dt. 1-11-2013, sanction is hereby accorded an amount of Rs.10,00,000/- (Rupees Ten lakhs only) to Sri Dammalapati Srinivas, Advocate General of A.P. towards his professional fee and Rs.3,00,000/- (Rupees three lakhs only) to Sri. D.Ramesh, Special Government Pleader towards Junior Counsel Fee. The applicable GST shall be paid by APGENCO on the said payments.

6) The Accounts Officer (CPR)/APGENCO is requested to arrange the payment by way of Cheque drawn in favour of Sri Dammalapati Srinivas, Learned Advocate General of A.P, PAN No.ABVDP 5660R and his junior advocate Sri D.Ramesh, PAN No.ADXPD 0482D for the amount sanctioned in Para-5 above.

7) The above payment of "Fee" is registered in the Register of "Legal Fee & Expenses" maintained in the Legal Cell at Sl.No.02/2018.
