ORDER:

In the reference 6th read above, the APGENCO has framed certain “Regulations governing the payment of “Legal Fee’ and “Expenses” to the Standing Legal Adviser, Board Legal Counsel and other Legal Counsel” appointed by the APGENCO from time to time, as indicated in the “Schedule of Fee” appended to the said order.

2) In the reference 7th read above, the APTRANSCO has enhanced the “Fee and Expenses” payable to their Standing Legal Advisers and other Legal Counsel in certain legal proceedings. The APGENCO has accorded its approval for the enhancement of the “Fee and Expenses” payable to the SLA to APGENCO and other Legal Counsel appointed by APGENCO on par with APTRANSCO.

3) Accordingly, in modification of the “Schedule of Fee” appended to the orders 6th read above, revised/modified Regulations governing the payment of “Legal Fee” and Expenses” as indicated in the “schedule of Fee” appended to this order are hereby framed and they shall be applicable only to the Standing Legal Advisers and other Legal Counsel appointed by the APGENCO from time to time. The revised/modified Regulations governing the payment of “Legal Fee” and Expenses” to the Standing Legal Advisers and other Legal Counsel as follows:

4) The Standing Legal Advisers and other Legal Counsel appointed by the APGENCO from time to time shall execute an undertaking to the effect that they shall abide by the terms and conditions of their appointment, payment of "Legal Fee" and "Expenses" as fixed by the APGENCO from time to time.

5) The other terms and conditions stipulated in the reference 6th cited remain unaltered. The applicable GST shall be paid on the payments to the SLA,BLC and other legal Counsels.

6) The revised/modified Regulations governing payment of "Legal Fee" and "Expenses" to the SLA,BLC and other Legal Counsel as framed in Para-3 above shall come into force with effect from **24.04.2018** that is the date of enhancement of "fee & Expenses" payable to SLAs and other Legal Counsel by the APTRANSCO in reference 7th read above enhancing the "Fee & Expenses" as indicated in the "Schedule of Fee" annexed to said orders. This order shall come into force with immediate effect. The pending bills shall be settled as per earlier orders. The claims already settled will not be reopened.
