**ORDER :**

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri P.Md.Sajid Ali Khan, Junior Personnel Officer is promoted temporarily to act as Personnel Officer with effect from the date of assumption of charge.

- 02) The promotion ordered in para –1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
- 03) The promotion ordered in para –1 above is subject to the result of S.L.P.Nos.2360 – 91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.
- 04) The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of Writ Petition No.16849 and others, pending before the Hon'ble High Court.
- 05) Sri P.Md.Sajid Ali Khan, Junior Personnel Officer O/o CGM(Adm,IS&ERP)/VS/VJA on promotion as Personnel Officer ordered above, is transferred and posted as Personnel Officer/IR/VIS/VJA in the existing vacancy under the control of Joint Secretary(Per)/VS/VJA duly terminating the full additional charge held by Sri N.V.S.J.Muralidhar, Personnel Officer/O&M vide reference 4<sup>th</sup> cited.
- 06) The Chief General Manager (Adm,IS&ERP) is requested to relieve the promotee by making local arrangements so as to enable him to join at the place of posting ordered.
- 07) He is directed to assume charge on promotion as Personnel Officer at the place of posting ordered. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt: 02.08.2008. Necessary departmental disciplinary

action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
