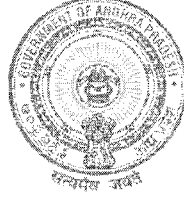

ORDER :

In the G.O first and second read above, orders were issued for continuation to draw the existing rate of House Rent Allowance (HRA) @ 30% of Basic Pay and CCA at the rates applicable in Hyderabad for a period of one year to the employees of the Secretariat and Heads of Departments and other offices who migrated from Hyderabad on shifting the Government Offices to New Capital City of Amaravathi. In the G.O third read above, orders were issued continuing these orders for another year from 07.06.2017.

2. In the references fourth to sixth read above, the Associations have requested the Government to continue the higher rate of 30% H.R.A. and C.C.A., as applicable in Hyderabad to the employees who migrated from Hyderabad on shifting the Government Offices to New Capital City of Amaravathi and on relocation of Government offices from Hyderabad to the new Capital Region.

3. Government after careful examination of the matter hereby continue the orders issued in the G.Os. first and second read above for a further period upto 30.06.2019

4. These orders do not apply to CRDA staff and other local staff working in the Amaravati region.

5. These orders also do not apply to the employees who have not shifted from Hyderabad to New Capital Region after bifurcation of the State or who are newly appointed or work on transfer or on deputation basis in these offices in the new capital region from district offices and other places. However, these employees may draw HRA, CCA as applicable to these offices as per existing rules.
