ORDER:

The APGENCO after careful consideration hereby issue regulations for fixation of fee to Advocate on Record(AOR)s for appearing before the Honble Supreme Court of India on behalf of APGENCO in all single cases and batch cases whenever their services engaged is as follows:

(i) For single cases

1	Fee for drafting and filing the Appeal/ Counter	50,000
2	If the case is disposed/dismissed on the first day	50,000
3	If not, Fee for the work done and assisting to Sr.Advocate (up to admission stage)	1,00,000
4	Fee for appearance per day (after admission of the case) (where the business is not transacted)	50,000
5	Fee for appearance (where the business is not transacted)	No fee will be paid
6	Court fee and expenses	As per actuals
7	Clerkage	@ 10% on appearance

(ii) For batch cases

SI.No.	Details	Amount (in Rs.)
1	Fee for drafting the Appeal/Counter 2 to 10 cases – 50% of the fee in first case 11 to 20 cases – 20% of the fee in first case Above 21 cases – 10% of the fee in first case	50,000 (for first case)
2	If the case is disposed/dismissed on the first day	50,000
3	If not, Fee for the work done and assisting to Sr.Advocate	1,00,000 (For first case)
4	Fee for appearance per day (after admission of the case) (where the business is not transacted)	50,000
5	Fee for appearance (where the business is not transacted)	No fee will be paid
6	Court fee and expenses	As per actuals
7	Clerkage	@ 10% on appearance
