ORDER:

Under Article 227, 230 and 231 of the A.P.F.C.Vol-I as adopted by the Board and in exercise of the Powers conferred on him in B.P.No.233, dt. 24.03.1976 read with B.P.Ms.No.449, dt. 16.12.1993 and B.P.Ms.No.226, dt. 13.01.1999, the Deputy Secretary (Estt) accords sanction for the Motor Cycle Advance to the employees as indicated in the Annexure appended to this order.

- 2) The advance sanctioned in Para-1 above carries interest at 5½% per annum for Motor Cycle. The advance shall be recovered in monthly installments. The principal amount shall be recovered in **80 monthly** installments commencing from the month following the month in which the loan is paid and interest thereon shall be recovered in **16 monthly** installments after the entire principal loan is repaid.
- 3) The advance sanctioned should be drawn before the end of the financial year 2018-2019.
- 4) The loanee should purchase the Motor Cycle within one month from the date of drawal of the advance and he/she should immediately hypothecate the Motor cycle as per Memo No.DS(Ser)/DM(BM)/PO(L)/2/3148/94-1, Dt.05.01.95 and also insure the vehicle as required under Article 230 of A.P.F.C. Vol-I. The Insurance policy should be renewed every year and a Photostat copy of the same should be submitted to APGENCO for verification.
- 5) The loanee shall get the Motor Cycle purchased with loan amount advanced to him into the premises of Vidyut Soudha for inspection by the Assistant Secretary (Estt). The Assistant Secretary (Estt.) after inspection of the vehicle and after verifying the purchase bills etc., shall send a certificate to the Accounts Officer/CPR/APGENCO to the effect that he has verified the vehicle and the relevant documents.
- 6) The loanee shall produce a certificate within one month from the date of drawal of advance to the Accounts Officer/CPR/APGENCO to the effect that the advance was solely utilized in purchasing the Motor Cycle. Also a certificate to the effect that the Motor Cycle is in her/his name and in her/his possession and is in running condition should be furnished to the Accounts Officer/CPR/APGENCO every month till the advance is repaid in full.

- 7) If the cost of the Motor Cycle purchased is less than the advance drawn, the balance amount should be refunded forthwith to the APGENCO.
- 8) The Motor Cycle when purchased will be the property of APGENCO until the advance is completely repaid. It should not be sold or otherwise disposed off without the permission of APGENCO, and in the event of such a sale or disposed sale proceeds should be remitted to the APGENCO towards, the repayment of the advance.
- 9) The agreement and surety bonds should be submitted by the loanee in the form as approved in B.P.Ms.No.156, dt. 23.03.1968.
- 10) The expenditure sanctioned in Para-1 above is debitible to the Head Accounts No .105500.
