ORDER:

Under Regulation 14 (a) (1) of APSEB Service Regulations Part-II as adopted read with G.O.O.No.555/JS(Per)/2008, dtd. 16.02.2009, Sri M.Raja, Station Fire Officer is promoted temporarily to act as Assistant Divisional Fire Officer with effect from the date of assumption of charge.

- 2) The promotion ordered in para -1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

- 3) The promotion ordered in para –1 above is subject to the result of S.L.P.Nos.2360 – 91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.

- 4) The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014.

- 5) Sri M.Raja, Station Fire Officer, SDSTPS/APPDCL on promotion as Assistant Divisional Fire Officer is transferred and posted on deputation to APPDCL at SDSTPS in the existing vacancy.

- 6) The concerned controlling officer is requested to relieve the promotee by making local arrangements within 15 days from the date of issue of this order, so as to enable him to join at the place of posting ordered.

7) Sri M.Raja, Station Fire Officer is requested to assume charge on promotion as Assistant Divisional Fire Officer at the place of posting ordered. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel year and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued vide G.O.O.No.231/JS(Per)/2008, dtd. 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
