ORDER

In the reference 5th cited, Sri D.Koteswara Rao, SI was requested to remit an amount of Rs.4868445.00 (inclusive of interest upto 31.08.2017) on or before 30.09.2017 by way of DD/Cheque/On line transfer to SBI Specialized Mid Corporate Branch, Vijayawada, Account No:52077965022, so as to enable this office for issue of re-induction orders. An amount of Rs 1290.40 towards interest on pensionary benefits to be added, per day, till date of remittance. The DD should be drawn in favour of Pay Officer /APGENCO.

2. In the reference 6th cited orders were issued that the period of remittance of pensionary benefits by the employees who retired at the age of 58 years for reinstatement up to 31.10.2017.

3. Further In the Memo.7th cited, It has been ordered that " the employee, who retire at the age of 58 years and who is unable to remit back the said terminal benefits, he/she need not remit the same(expect Retirement Gratuity)but on his /her re-induction he/she shall pay the interest@9% per anum on the amounts received towards terminal benefits, during his /her future tenure(i.e for the period from the date of re-induction to the date of retirement at 60 years)and if the said interest amount is not paid ,such interest amount shall be deducted from his /her monthly salary".

4. Accordingly, In the reference 8th cited ,Sri D.Koteswara Rao, SI (Retd) was requested to remit Rs.12,00,000/- (Rupees Twelve Lakhs only) the amount of Retirement Grauity already paid to him and furnish option along with undertaking on or before 31.01.2018 in order to enable this office to issue re-induction orders.

5. In the referenc e 9th cited, Sri D.Koteswara Rao, SI has represented that he deposited an amount of Rs. 12,00,000/- (Rupees Twelve Lakhs only)on 03.01.2018 to APGENCO duly enclosing the undertaking of accepting the conditions stipulated vide Memo 7th cited.

6. After careful consideration, Sri D.Koteswara Rao, SI (Retd) (retired on 31.07.2016 AN) is hereby re-inducted in to service of APGENCO as SI with effect from 28.12.2017 and posted as Security inspector under the control of CE/O&M/Dr.NTTPS subject to the conditions mentioned in the Memo 7th cited.
