ORDER

In the reference 1<sup>st</sup> cited, Sri. R.Rama Chandra Raju, PS to Principal Secretary to Government (Retd) was appointed as OSD to Chairman, APGENCO on contract basis for a period of one year w.e.f. 27.08.2012 with consolidated remuneration of Rs.32,000/- (Rupees thirty two thousand only) per month and is not eligible for any allowances/incidental etc. The contract period was extended from time to time upto 27.08.2017.

2. In the reference 5<sup>th</sup> cited the remuneration was enhanced to Rs.50,000/- (Rupees fifty thousand only) from the date of extension of his term i.e.27.08.2015. In the reference 6<sup>th</sup> cited the contract period of Sri. R.Rama Chandra Raju, OSD to Chairman was extended for a further period of one year and the remuneration was also enhanced to Rs.65,000/- (Rupees Sixty five thousand only). In the reference 7<sup>th</sup> cited the period of contract as OSD to Chairman, APGENCO was extended for a further period of one year w.e.f 27.08.2017 and the remuneration was also enhanced to Rs.70,000/- (Rupees Seventy thousand only).

3. In the reference 8<sup>th</sup> cited he has requested for extension of contract appointment as OSD to Chairman, APGENCO for a further period of one year w.e.f.27.08.2018 and also to enhance the remuneration by 30% on present emoluments.

4. After careful consideration, it is hereby ordered that the contract period of Sri. R.Rama Chandra Raju, OSD to Chairman, APGENCO shall be extended for a further period of one year w.e.f.27.08.2018 on the same terms and conditions in the GOO cited and also the remuneration is enhanced to Rs.87500/- (Rupees Eighty seven thousand and five hundred only) from the date of extension of his term.
