ORDER :-

APGENCO is engaging Outsourced workers on need basis through 3rd Party Agencies/Contractors in the Highly Skilled, Skilled, Semi-skilled, Un-Skilled categories.

02). In the APPCC meeting held on 20.02.2018, it was decided to provide Group Insurance coverage to the outsourced workers working in A.P.Power Utilities up to Rs.10,00,000/- (Rupees Ten lakhs only) per person duly inviting tenders from the Insurance Companies.

03). The APTRANSCO, on behalf of the AP Power Utilities, invited quotations from the four Public Sector Insurance Companies. After deliberate negotiations, M/s United India Insurance Company Limited Vijayawada, has quoted lowest premium of Rs.400/- + GST 18% as applicable per person, per annum for providing Insurance for a policy amount of Rs.10,00,000/- (Rupees Ten Lakhs only) for Accidental Death and disability including Medical Extension.

04). The APTRANSCO, vide T.O.O.(Addl.Secy-Per) Ms.No.1034, Dt.20.12.2018 accepted the offer of M/s United India Insurance Company Limited, Vijayawada for providing of insurance policy for an amount of Rs.10,00,000/- (Rupees Ten Lakhs only) to the outsourced workers working through 3rd party Agencies in AP Power Utilities. The amount of insurance payable under the said policy to cover, when an accidental injury and cause results (during the period of Insurance) is as follows :-

Sum insured :-

Capital Sum Insured per life is Rs.10,00,000/-

05). The compensation received under this scheme does not disentitle the victim or the dependants of deceased for any other amounts under the law in force other than this policy.

After careful consideration, the APGENCO hereby concur with the offer agreed by APTRANSCO, as mentioned at para 4 above, and hereby agreed for providing Insurance of Rs.10,00,000/- (Rupees Ten lakhs only) to the each of Outsourced workers engaged through 3rd Party Agencies in APGENCO in line with the orders issued vide TOO cited.
