05) The list of Junior Personnel Officers on promotion as Personnel Officers ordered above, are transferred and posted to the places mentioned against their names in the Annexure appended to this order.

06) The concerned controlling officers are requested to relieve the promotees by making local arrangements so as to enable them to join at the place of posting ordered.
