ORDER:

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, Sri P Seetharam, Deputy Executive Engineer (Civil) is promoted to act temporarily as Executive Engineer (Civil) with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. It is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.

3. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of ;

- a) The Judgment to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgment in W.P.No.2360-91/1983.
- b) The Judgment to be delivered in W.P.Nos.8509/1988 and 10937/1989 pending before the Hon'ble High Court of A.P.
- c) The Judgment to be delivered in W.P.No.3470/2008 and W.P.No.1597/2010 pending before the Hon'ble High Court of A.P. and
- d) Result of final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Reorganisation Act.,2014.

4. Sri P Seetharam, Deputy Executive Engineer (Civil) on temporary promotion as Executive Engineer (Civil) is transferred and posted to the control of Executive Director (Civil)/ Vidyut Soudha/Vijayawada.

5. The Executive Director (Civil) is requested to relieve the above DEE(Civil) immediately by making local arrangements so as to enable him to join as Executive Engineer(Civil) on promotion.

7. Sri P Seetharam, DEE(Civil) is requested to assume charge on promotion as Executive Engineer (Civil) at the place of posting within 10 days from the date of relief. If he fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, his promotion rights shall be forfeited for the current panel year and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders. No request for change of posting or sanction of leave will be entertained.
