ORDER:

Under Regulation 14(a)(1) of APSEB SRs Part-II, as adopted by APGENCO, in continuation of the orders issued in the G.O.O.s cited and in pursuance to the Hon'ble High Court orders vide reference 4th cited, the candidates mentioned in the annexure appended to this orders are appointed temporarily by Andhra Pradesh Power Generation Corporation Limited as Trainee Assistant Engineers (now re-designated as Assistant Executive Engineer) in the time scale of pay of Rs.60155-2485-65125-2900-79625-3335-92965 with usual allowances admissible from time to time and he/she is placed on training for a period of one year.

2. The appointment of Trainee Assistant Engineers (now re-designated as Assistant Executive Engineer) is provisional and liable for termination at any time without notice and without assigning any reasons.

3. The conditions of service of the candidates will be governed by the rules and regulations applicable as framed or as amended by Andhra Pradesh Power Generation Corporation Limited from time to time. The Tripartite Agreement entered into among the erstwhile APSEB, Govt of A.P. and Employees Associations are not applicable to the candidate and he/she shall at no stage be entitled to claim any right whatsoever arising out of the said Tripartite Agreements. The candidates have already submitted an undertaking to this effect along with the following Original Documents submitted on 12.06.2019 and 05.08.2019.

- i. Documentary evidence of Educational Qualifications viz., Degree in Engineering Certificate as reported in his/her application for appointment.
- ii. Documentary evidence of age viz., SSC/ICSE/CBSE or Date of Birth Certificate issued by the competent authority.
- iii. Documentary evidence of Caste Certificate (latest by 6 months/Permanent).
- iv. Certificate of Residence/School Study Certificate.
- v. Local Status Certificate (FORM-III)(as per G.O.Ms.No.132 & 133, GA (SPF&MC)Department, dt.13.06.2016 and circular Memo No.4136/SPF&MC/2015-5, Dated:08.08.2016 & Memo No.4136/SPF&MC/2015-9, dtd:03.09.2016) issued by Tahsildar, if migrated to Andhra Pradesh.
- vi. Employment Exchange Registration Card, if any.
- vii. Certificate of Physical Fitness issued by a Govt. Medical Officer of rank not lower than that of Civil Surgeon (or) District Medical Officer.
- viii. Certificate issued by the District Medical Board in respect of physically challenged.
- ix. A bond on non-judicial stamp paper worth Rs.100/-(Rupees One hundred only) shall be executed to the effect that;
 - a) He/She will serve the CORPORATION for a minimum period of 5 years after completion of training, in case he/she is appointed on regular basis;
 - b) If the candidate leaves the CORPORATION during the period of training, he/she shall refund to the Corporation the emoluments received by him/her during Training period plus Rs.50,000/- (Rupees fifty thousand only) by way of liquidate damages.

- c) If the candidate leaves the Corporation, during the bond period, he/she shall pay to the Corporation an amount of Rs.1,00,000/- (Rupees One lakh only) by way of liquidated damages. The original documents will be retained until agreement period is over.
4. The appointment order is subject to the following conditions; namely;
- The appointment is subject to verification of character and antecedents. If any adverse report is received in the said verification, his/her services are liable for termination without notice.
 - The original certificates deposited with APGENCO will be retained with the Corporation for a period of six years i.e. 1 year, Training Period plus 5 years. However, the APGENCO may consider for return of original certificate on temporary basis to the candidate after completion of three years from the date of joining on written request after depositing caution money of Rs.50,000/- (Rupees Fifty thousand only) with APGENCO which will be refunded on re-depositing back the original Documents to the Corporation.
 - The candidate appointed as Trainee Assistant Engineer (now re-designated as Assistant Executive Engineer) shall work wherever he/she is posted and no request for change of posting will be entertained.
5. The candidate appointed as Trainee Assistant Engineer (now re-designated as Assistant Executive Engineer) is posted to the places noted against their names in the Annexure appended to this orders. They will be on job training at the place of posting ordered during the training period.
6. He/she is requested to report at the place of posting ordered above duly producing Appointment order along with the acknowledgement slip issued by Assistant Secretary (Administration)/VS/Vijayawada. If he/she does not report at the place of posting within a period of 30 (thirty) days from the date of receipt of the order, the offer of appointment shall automatically stands cancelled and the name of the candidate shall be omitted from the list of approved candidates and the appointment orders as Trainee Assistant Engineers (now re-designated as Assistant Executive Engineer) will be cancelled without any further notice.
7. The provisions of EPF & MP Act 1952 and the Employees Provident Funds Scheme 1952 are applicable to the candidate in terms of G.O.O.No. 708/GM(Adm)/2002, Dated: 06.02.2003.
