ORDER:

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, Sri E. Bhadraiah, Deputy Executive Engineer (Elecl.) is promoted to act temporarily as Executive Engineer (Elecl.) with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. It is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.

3. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of ;

- a) W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court and W.P.Nos.77074/93, 17126/93, 5221/93, 10199/92 pending in the High Court of A.P.
- b) W.P.No.19836/2000, W.P.No.3470/2008 and 14264/2009 pending before the Hon'ble High Court of A.P, and
- d) Result of final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Re-organisation Act.,2014.

4. Sri E. Bhadraiah, Deputy Executive Engineer (Elecl.) working under the control of CE/Construction/SDSTPS on deputation, on temporary promotion as Executive Engineer (Elecl) is repatriated to APGENCO and posted under the control of CE/O&M/Dr.NTTPS.

5. The CE/Construction/SDSTPS is requested to relieve the above Deputy Executive Engineer (Elecl.) by making local arrangements so as to enable him to join as Executive Engineer (Elecl.) on promotion at the place of posting ordered.

6. The Deputy Executive Engineer (Elect.) is requested to assume charge on promotion as Executive Engineer (Elect.) at the place of posting within 10 days from the date of relief. If he fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, his promotion rights shall be forfeited for the current panel year and the name of the candidates shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders. No request for change of posting or sanction of leave will be entertained.
