In the G.O. 6<sup>th</sup> read above, the Government of Andhra Pradesh have appointed Sri.M.Vidyasagar, Advocate, as Standing Counsel for the Andhra Pradesh Power Generation Corporation Limited (APGENCO) in the High Court of Andhra Pradesh for a period of 3 (three) years from the date of assumption of charge of the post or till termination of his services, whichever is earlier. It was also ordered therein that the service conditions mentioned in G.O. first read above as amended from time to time are applicable to him and the honorarium shall be paid as per the orders issued in the reference 5<sup>th</sup> cited.

In the reference 7<sup>th</sup> cited, Sri.M.Vidyasagar, SLA/APGENCO has given his acceptance of appointment as SLA/APGENCO as per the orders issued by the Law Department vide G.O.Rt.No.213, Law (G) Department, Dated 27-08-2019. He has also given his willingness accepting the terms and conditions with regard to payment of "Fee & Expenses" as specified in G.O.O.No.158/JS(Per)/2018, dt.11.05.2018 and G.O.O.No.504/CS/2013, dtd.01-11-2013 vide his letter 7<sup>th</sup> cited.

3. After careful consideration, the APGENCO hereby adopts the orders issued in G.O.Rt.No.213 Law (G) Department dated 27.08.2019, 6<sup>th</sup> read above by appointing Sri.M.Vidyasagar, Advocate as SLA to A.P.Genco for a period of 3 (three) years.

4. Consequent upon his appointment as SLA to APGENCO, Sri.M.Vidyasagar, Advocate, is required to appear on behalf of APGENCO in the Hon'ble High Court or in any other Court or Tribunal or Forum as provided in the Regulations made under Section 79-(k) of the Electricity (Supply) Act, 1948 contained in B.P.Ms.No.998, dtd.07-12-1981 in connection with:-

of "Legal Fee" for professional services rendered by him and "Expenses" incurred on behalf of APGENCO in conducting the legal proceedings mentioned in the "Schedule of Fee" appended to above said G.O.O.

7. The appointment of Sri.M.Vidyasagar, Advocate, as SLA to APGENCO is also subject to the Regulations made under Section 79- (k) of the Electricity (Supply) Act, 1948, governing the "**Appointment and Payment of Fees to SLAs and other Legal Counsel**" as framed by the erstwhile A.P.S.E Board in its B.P.Ms.No.998, dtd.07-12-1981 and as amended by APGENCO in G.O.O.No.158/JS(Per)/2018, dt.11.05.2018 and G.O.O.No.504/CS/2013, dtd.01-11-2013 and also subject to the amendments ordered to the aforesaid Regulations from time to time, apart from the service conditions mentioned in the G.O. first read above.

8. The other terms and conditions mentioned in the G.O. first read above are unaltered.

9. This order issues with the concurrence of the Director (Finance & Commercial)/A.P.GENCO vide E-Office Letter dated 04-09-2019.
