4) The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014.

5) The Assistant Accounts Officers as mentioned above, on promotion as Accounts Officers are transferred and posted to the places noted against their names in the Annexure appended to this order.

6) The concerned controlling officers are requested to relieve the above Assistant Accounts Officers by making local arrangements within 15 days from the date of issue of this order. On expiry of 15 days they shall be deemed to have been relieved from the present place of working.

7) They are directed to assume charge on promotion as Accounts Officers at the places of posting ordered. If they fail to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, their promotion right shall be forfeited for the

current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(Per)/08, Dt: 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
