Order:

2) As per the delegation of Powers ordered in G.O.O.No.129/JS(Per)/2016, dated 15.07.2016, the functional head in the rank of Chief Engineer/FA&CCA is competent to sanction the “Legal Fee and Expenses” as per approved scales as per which the Chief General Manager(Adm, IS &ERP) is Competent to sanction the above professional fee to Sri.C.Sumon, Government Pleader.
