ORDER:

- c) Result of final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Reorganisation Act.,2014,

4. Sri K. Venkateswarlu, Executive Engineer (Elecl) on temporary promotion as Superintending Engineer (Elecl.) ordered above is posted as Superintending Engineer (Elecl.) under the control of Chief Engineer/HPC&HP/Vidyut Soudha/Vijayawada vice, Sri. P.Sivaramanjaneyulu, Superintending Engineer (Elecl.) transferred.

5. On relief, Sri. P.Sivaramanjaneyulu, Superintending Engineer (Elecl.) working under the control of Chief Engineer/HPC&HP/Vidyut Soudha/Vijayawada is transferred and posted to the control of Chief Engineer/TPC/Vidyut Soudha/Vijayawada in the existing vacancy duly terminating the additional charge held by G.Rama krishnudu, Superintending Engineer (Elecl.).

7. Sri K. Venkateswarlu, Executive Engineer (Elect) is requested to assume charge on promotion as Superintending Engineer (Elect.) at the place of posting ordered above. If he fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, his promotion rights shall be forfeited for the current panel year and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O.1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders. No request for change of posting or sanction of leave will be entertained.


