ORDER :

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri D.Prabhakara Rao, Deputy Manager (HR) is promoted temporarily to act as Deputy General Manager (HR) with effect from the date of assumption of charge.

02) The promotion ordered in para–1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

03) The promotion ordered in para–1 above is subject to the result of S.L.P.Nos.2360 – 91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.

04) The promotion ordered above is subject to review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014.

05) After careful consideration, one vacant post of Deputy General Manager (HR) at RTPP is temporarily diverted to the control of Chief Engineer/O&M/LSHES with immediate effect.

06) Sri D.Prabhakara Rao, Deputy Manager (HR) O/o CE/O&M/LSHES on promotion as Deputy General Manager (HR) ordered above, is transferred and posted to the control of CE/O&M/LSHES against the post diverted in para (5) above.

07) The Chief Engineer/O&M/LSHES is requested to take necessary action accordingly.

08) He is directed to assume charge on promotion as Deputy General Manager (HR) at the place of posting ordered. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/2008, Dt: 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
