**ORDER :**

  - b) W.P.No.19836/2000, W.P.No.3470/2008 and 14264/2009 pending before the Hon'ble High Court of A.P, and
  - c) Result of final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Reorganisation Act.,2014, besides subject to the outcome of batch of writ petitions, No.16849/2015 and others pending before the Hon'ble High Court of Judicature at Hyderabad.
  - d) Batch of writ petitions, No.16849/2015 and others, pending before the Hon'ble High Court of Judicature at Hyderabad.
6. The above post of Executive Director (Civil) shall be downgraded to CE(Civil) as and when Sri K. Ratna Babu vacates the post.
7. Sri K Ratna Babu, CE/Civil/Hydel/GS/C&I/Vidyuth Soudha/Vijayawada is requested to assume charge accordingly.
