ORDER:

- 04) The promotion ordered above is subject to review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014. The Promotion ordered above is also subject to the review of the Roster on receipt of the clarification from the Government of A.P in response to the Lr.No. D(HR)/JS(P)/DS(Estt)/AS(IR)/PO-H/78/2018, Dated:22.01.2019.
- 05) After careful consideration, one vacant post of Dy.CCA at VS/VJA. is temporarily diverted to 5x100 MW PV Solar Plant, Tadipatri O/o CE/O&M/SRBPH with immediate effect.
- 06) Sri C.V.Ramana Rao, Senior Accounts Officer, 5x100 MW PV Solar Plant, Tadipatri O/o CE/O&M/SRBPH, on promotion as Dy.CCA ordered above, is posted at 5x100 MW PV Solar Plant, Tadipatri, under the control of CE/O&M/SRBPH.
- 07) The CE/O&M/SRBPH is requested to take necessary action accordingly.

If he fail to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt: 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
