**ORDER :**

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, the following Junior Personnel Officers are promoted temporarily to act as Personnel Officers with effect from the date of assumption of charge.

- 02) The promotion ordered in para –1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
- 03) The promotion ordered in para –1 above is subject to the result of S.L.P.Nos.2360 –91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.
- 04) The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of Writ Petition No.16849 and others, pending before the Hon'ble High Court.
- 05) After careful consideration, one post of Personnel Officer from the control of CE/Civil/Hydel/VS/VJA. is temporarily diverted to the control of CE/Gen/VS/VJA. from the date of actual utilization.
- 06) The list of Junior Personnel Officers on promotion as Personnel Officers ordered above, are transferred and posted to the places mentioned against their names in the Annexure appended to this order.
- 07) The concerned controlling officers are requested to relieve the promotees by making local arrangements so as to enable them to join at the place of posting ordered.

08) They are directed to assume charge on promotion as Personnel Officers at the place of posting ordered. If they fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, their promotion right shall be forfeited for the current panel year and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt: 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
