ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri K.Venkata Reddy, Assistant Accounts Officer is promoted temporarily to act as Accounts Officer with effect from the date of assumption of charge.

- 2) The promotion ordered in para –1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
- 3) The promotion ordered in para –1 above is subject to the result of S.L.P.Nos.2360 – 91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.
- 4) The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014.
- 5) After careful consideration, 1 (one) vacant post of Accounts Officer under the control of CE/O&M/Dr.NTTPS is temporarily diverted to the control of SE/Civil/O&M/Upper Sileru. The existing AAO post at USHES is temporarily diverted to the control of CE/O&M/Dr.NTTPS.
- 6) Sri K.Venkata Reddy, Assistant Accounts Officer O/o SE/Civil(O&M)/Upper Sileru on temporary promotion as Accounts Officer ordered in para – 1 above is posted to the control of SE/Civil (O&M)/Upper Sileru against the diverted post at para 5above.
- 7) Sri P.Rama Krishna, Assistant Accounts Officer/APPDCL/VJA. who stands promoted as Accounts Officer/Machkund vide G.O.O. 4th cited is transferred and posted to the control of CE/O&M/SRBPH in the existing vacancy.
- 8) The concerned controlling officers are requested to relieve the above Assistant Accounts Officers by making local arrangements within 15 days from the date of issue of this order. On expiry of 15 days they shall be deemed to have been relieved from the present place of working.

9) They are directed to assume charge on promotion as Accounts Officers at the places of posting ordered. If they fail to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, their promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(Per)/08, Dt: 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
