ORDER:

Under Regulation 14 (a)(1) of APSEB Service Regulations Part-II as adopted by APGENCO, Sri/Smt/Kum._____ (H.T.No._____) is selected provisionally by APGENCO for appointment as Trainee Junior Accounts officer in the time scale of pay of Rs.50615-2085-52700-2485-65125-2900-79625- 3335-82960 with usual allowances admissible from time to time and he/she is placed on training for a period of one year from the date of his/her joining.

2. The appointment is provisional and liable for termination at any time without notice and without assigning any reasons.
3. He/she will be governed by the Rules and Regulations in vogue and as framed or as amended by APGENCO from time to time. The Tripartite agreement entered into among erstwhile APSEB, Government of AP and the employees associations/unions is not applicable to the candidate and he shall at no stage be entitled to claim any right whatsoever arising out of the said Tripartite agreement. He/She has to submit an Undertaking to this effect.
4. The candidate appointed as Trainee Junior Accounts officer is posted to-----
He/She shall undergo training for a period of 1 year from the date of joining. He/she shall also undergo induction training as determined by the APGENCO soon after joining.
5. The candidate is directed to maintain a diary in which he/she should write about all the works he/she has attended during the training period. This diary should be submitted once in a week to the respective controlling officer for security and remarks duly signed.
6. The original certificates, as detailed below, submitted with the corporation shall be retained for a period of 6 years inclusive of 1 year Training period. However, the APGENCO may consider for return of original certificates on temporary basis after completion of 3 years from the date of joining in case of a written request from the candidate duly depositing caution money of Rs. 50,000/- (Rupees fifty thousand only) with APGENCO which will be refunded on re-depositing back the original certificates to APGENCO. The attestation forms in quadruplicate, physical fitness certificates and Under taking submitted by him/her are retained in Corporate office.

- i) Certificate of Educational qualification (viz. The Degree certificate of M.Com 1st class/CA(Inter)/B. Com 1st class/ICWAI (inter)
- ii) Documentary evidence of age (i.e. certificate of SSC/BSE/ICSE of any other equivalent there to)
- iii) Documentary evidence of caste in respect of candidates belonging to BC,SC, and ST communities.
- iv) Employment Exchange Registration card if any,
- v) Medical certificate from District Medical Board in case of Physical challenged candidates.
- vi) Certificate of Residence/School Study certificate.

7. The appointment ordered now is subject to verification of Character and Antecedents.

8. A Bond on non-judicial stamp paper worth Rs. 100/- (Rupees one hundred only) shall be executed to the effect that:

- i) He/she will undergo the training for a period of one year failing which he/she will refund the monthly emoluments received by him/her from the date of joining to the date of relief plus an amount of Rs. 50,000/- (Rupees fifty thousand only by way of liquidated damages.
- ii) That he/she will serve the APGENCO for a minimum period of 5 years after completion of training. If appointed on regular basis failing which he shall have to pay an amount of Rs. 1,00,000/- (Rupees one lakh only) by way of liquidated damages.

(A bond on non-judicial stamp paper has already been submitted by him/her is retained in corporate office)

9. The candidate is requested to report at the place of posting as ordered in para 4 above along with a copy of the acknowledgement slip issued by Assistant Secretary (Estt). He/She is informed that no request for change of posting on the grounds of spouse working shall not be entertained. If the candidate does not report at the place of posting with in a period of 30 (thirty) days from the date of receipt of this order, the offer of appointment shall automatically stands cancelled and the name of the candidate shall be omitted from the list of approved candidates and the appointment orders as Trainee Junior Accounts officer will be cancelled with out any further notice.

10. The candidates will be governed by the governed by the provisions of EPF & MP Act 1952 and the Employees provident Fund scheme 1952 in terms of the orders issued in GOONO. 708/GM(A)/2002, dt. 06.02.2003.
