5. Sri L. Narasimhulu, Superintending Engineer (Elect.) on temporary promotion as Chief Engineer (Elect.) is posted as Project Manager/GGPP/Jegurupadu on deputation basis. The functions of Project Manager GGPP/Jegurupadu entrusted to CE/Generation/VS/Vijayawada vide memo 5th cited are herewith restored back with effect from the date of joining of Project Manager/GGPP/Jegurupadu.
