ORDER:

In compliance of the directions contained in para 29 (I) of the Supplementary report dt.11-03-2020, read with clarificatory report dt.13.03.2020 of the Honourable One Man Committee, Sri./Smt.TIKKAYYA JAKKALAGOLLA, ADE/MECH. 5) Thus in compliance with the Concluding Report dated 20.06.2020 of the Honourable One Man Committee and Compliance Report dated 26.06.2020 submitted to Honourable One Man Committee and further orders thereon, the orders issued in the reference 9<sup>th</sup> read above duly allotting Sri./Smt.TIKKAYYA JAKKALAGOLLA, ADE/MECH. (now DY.EE/MECH) (EMP ID No.1073237) to TSGENCO on final allotment are hereby rescinded and Sri./Smt.TIKKAYYA JAKKALAGOLLA, ADE/MECH. (now DY.EE/MECH) (EMP ID No.1073237) is now re-allotted in APGENCO. He is directed to report to the MD/APGENCO/Vidyuth Soudha/Vijayawada to get reposting orders.
