ORDER:

MURTHY BVLN, AO (now PENSIONER) (EMP ID No.1062492) to TSGENCO on final allotment are hereby rescinded and Sri/Smt. MURTHY BVLN, AO (now PENSIONER) (EMP ID No.1062492) is now re-allotted in APGENCO.
