ORDER:

M.Paul Sundersingh CE/Elec., (now Pensioner) EMP ID No.1051799 to TSGENCO on final allotment are hereby rescinded and Sri./Smt M.Paul Sundersingh CE/Elec., (now Pensioner).EMP ID No.1051799 is now re-allotted in APGENCO.
