ORDER:

EMP ID No.1061492 to TSGENCO on final allotment are hereby rescinded and Sri.P.V.L.Narasimha Rao,SE/Elec.(Now CE/Elec.) EMP ID No.1061492 is now reallocated in APGENCO. He is directed to report to the MD/APGENCO/Vidyut Soudha/Vijayawada to get reposting orders.
