ORDER:

B.Veera Rahava Prasad,DE/Elec.(now EE/Elec.) EMP ID No.1050258 to TSGENCO on final allotment are hereby rescinded and Sri. B.Veera Rahava Prasad,DE/Elec.(now EE/Elec.)
