ORDER:

5) Thus in compliance with the Concluding Report dated 20.06.2020 of the Honourable One Man Committee and Compliance Report dated 26.06.2020 submitted to Honourable One Man Committee and further orders thereon, the orders issued in the reference 9<sup>th</sup> read above duly allotting Sri./Smt. T.Venkateswara Rao,DE/Elec.(now EE/Elec.) EMP ID No.1022223 to TSGENCO on final allotment are hereby rescinded and Sri. T.Venkateswara Rao,DE/Elec.(now EE/Elec.) EMP ID No.1022223 is now re-allotted in APGENCO. He is directed to report to the MD/APGENCO/Vidyut Soudha/Vijayawada to get reposting orders.
