A.Somaiah,EE/Civil. EMP ID No.1070265 to TSGENCO on final allotment are hereby rescinded and Sri. A.Somaiah,EE/Civil. EMP ID No.1070265 is now re-allotted in APGENCO. He is directed to report to the MD/APGENCO/Vidyut Soudha/Vijayawada to get reposting orders.
