AP Reorganisation Act 2014 – Bifurcation of employees of Power Utilities between the states of Andhra Pradesh and Telangana – Concluding report dt: 20.06.2020 communicated by Hon'ble One-Man Committee – The dropped 46 employees out of 300 relieved from TSGENCO completing 58 years by 2020 – Payment of salaries to the balance 254 employees as per orders of Hon'ble Supreme Court Dt: 08.04.2020 for the Month of June 2020 payable in July 2020 – Instructions – Issued.

ORDER:

Hon'ble Justice Shri D.M. Dharmadhikari/ One-Man Committee communicated the concluding report dt: 20.06.2020 on final bifurcation of employees of AP Power Utilities between the states of Andhra Pradesh and Telangana in the reference 5th cited. In compliance of the directions of Hon'ble One-Man Committee, out of the 300 employees relieved from TSGENCO to APGENCO, the employees completing 58 years of age by 2020 shall be retained in TSGENCO.

2. In obedience of the direction (I) of Hon'ble One-Man Committee, 46 employees have been identified as completing 58 years of age by 2020 from among the 300 employees relieved from TSGENCO to APGENCO. The list of 46 employees has been submitted to Hon'ble One- Man Committee from S.No.1 to 46 in the annexure – C-1A vide compliance report dt: 26.06.2020 of the Member/ Sub-Committee/ AP Power Utilities in the reference 6th cited.

3. In obedience of the orders issued by Hon'ble Supreme Court of India and Hon'ble Justice D.M. Dharmadhikari/ One-Man Committee it is hereby ordered for payment of salaries for the 254 employees relieved from TSGENCO to APGENCO for the month of June 2020 payable in July 2020 through APPCC on temporary basis.

4. The FA&CCA(Audit &Trust) & FACCA(Accounts&Resources) shall take immediate action to comply with the above instructions and ensure that salaries are paid to the 254 employees relieved from TSGENCO for the month of June 2020 payable in July 2020 and send a compliance report.

5. The salaries shall be paid in full (100%) and action shall be taken for effecting all recoveries as usual. This payment of salaries is ordered only on temporary basis pending compliance of the directions of Hon'ble One-Man Committee from TSGENCO, to avoid hardship to the employees during the COVID-19 Pandemic situation as per the directions of Hon'ble One-Man Committee issued earlier.
