**ORDER:**

In terms of retirement notice issued in G.O.O. 1<sup>st</sup> cited, Sri. V.Vijaya Kumar was retired from service as Senior Accounts Officer on attaining the age of superannuation i.e.58 years on 30.04.2015 A.N. In G.O.Ms. No. 102, dtd. 27.06.2017, the Government of Andhra Pradesh has given its principle approval and conditional consent for extension of superannuation from 58 to 60 years to the employees of institutions listed in schedules IX and X of AP Reorganization Act, 2014. Accordingly, in G.O.O. 3<sup>rd</sup> cited, orders were issued enhancing the age of superannuation from 58 to 60 years to the employees of APGENCO with immediate effect. In G.O. Ms. No. 138, Finance (HR.IV-FR) dtd. 08.08.2017, the Government had amended para 5 of G.O. Ms. No. 102 to the effect that the orders shall come into force with effect from 02.06.2014. Based on these government orders, in the G.O.O. 4<sup>th</sup> cited, the APGENCO has also issued amendment to G.O.O. No. 86/JS(Per)/2017, dtd. 29.06.2017 substituting the words "with effect from 02.06.2014" in place of "with immediate effect." In G.O.O.5<sup>th</sup> cited, the APSEB Service Regulations were also amended to the above effect.

2. In Memo. 6<sup>th</sup> cited, while issuing instructions on enhancement of age of superannuation, at para 6 (e), it was ordered to reckon the period of seniority, promotions, Automatic Advancement Scheme. It was also ordered that the monetary benefits shall be paid from the date of attaining the age of 60 years.

3. In the representation 7<sup>th</sup> cited, Sri V.Vijaya Kumar, SAO (Retired) has requested for notional promotion as Dy.CCA on par with his juniors as per above orders.

4. Accordingly, the case of Sri V. Vijaya Kumar, SAO (Retired) was reviewed as to whether he is eligible for notional promotion as Dy.CCA on par with his junior in terms of Regulation 8 (2) (a) of APSEB Service Regulations Part-II as adopted by APGENCO or otherwise.

5. After careful consideration, it is hereby ordered that Sri V. Vijaya Kumar, SAO (Retired) shall be notionally promoted as Dy.CCA with effect from 12.08.2016 F.N. i.e. from the date of joining of his immediate junior Sri C.V.Ramana Rao in the cadre of Dy.CCA however monetary benefit shall be paid with effect from 30.04.2017 A.N. (i.e the date of his superannuation on attaining the age of 60 years). The notional promotion now ordered shall be for calculation of terminal benefits.

6. The notional promotion ordered above will be reviewed or cancelled, if necessary at any time without notice and without assigning any reasons thereto.
