ORDER:

In compliance of the directions contained in the Concluding Report dated 20.06.2020 read with Supplementary Report dated 11.03.2020 and Final Report dated 26.12.2019 of the Honourable One Man Committee, Sri/Smt.K.KRISHNA VINAYA VIBHUSHAN., Dy.Executive Chemist,(SR.CHEMIST as on 2.6.2014) (EMP ID No. 1069115) had been allotted to **APGENCO**, and was relieved from the services of TSGENCO and he/she was ceased to be the employee of TSGENCO. He/she was directed to report to the Managing Director/APGENCO/Vidyut Soudha/Vijaywada to get posting orders.

2) Thereafter, some stakeholders including affected employees and the TS Power Utilities have challenged the identification process, that was completed in terms of the Supplementary Report dated 11.03.2020. All objections were duly considered and are put to quietus by the Hon'ble Supreme Court vide order dated 08.04.2020, 01.05.2020, 03.06.2020 passed in MAs filed by various parties and the Concluding Report dated 20.06.2020 (9th cited) is submitted by the Honourable One Man Committee to the Hon'ble Supreme Court.

3) As such, identification of 584 employees to be finally allocated to T.S.Power Utilities is submitted to the Hon'ble One Man Committee and same is approved and are part of the Concluding Report dated 20.06.2020. The said 534 (after 50 getting dropped from the outgoing 584, as modified by Direction I, of the Concluding Report dated 20.06.2020) are relieved in reciprocal to 536 incoming to AP Power Utilities (after 119 getting dropped from the incoming 655 list as modified by Direction I, of the Concluding Report dated 20.06.2020) and the said orders passed by the Hon'ble One Man Committee are to be applied and implemented as the orders of the Hon'ble Supreme Court of India.

4) In addition to above, the further modifications as directed by Hon'ble One Man Committee in terms of the directions in the Concluding Report dated 20.06.2020 are also completed vide Compliance Report dated 26.06.2020 as submitted to the Hon'ble One Man Committee.

5) Thus, in compliance with the Concluding Report dated 20.06.2020 of the Honourable One Man Committee and Compliance Report dated 26.06.2020 submitted to Honourable One Man Committee and further orders thereon, the present orders are hereby issued. With due notice and subject to the litigation before any forum, if any, initiated by any stakeholder the instant orders will be modified/ cancelled/ amended/recalled subject to the outcome of the said proceedings. Needless to mention that the threshold limit as set out as per Modality No. III read with the Concluding Report dated 20.06.2020 has to be maintained for each utility on both the sides. And further note that no employee in excess of the GOs limit (Modality No. III) shall be admitted contrary to the Concluding Report dated 20.06.2020.

6) Therefore, subject to above, Sri/Smt.K.KRISHNA VINAYA VIBHUSHAN,SR.CHEMIST as on 2.6.2014, Now Dy.Executive Chemist (EMP ID No.1069115) is hereby posted as Dy.Executive Chemist at DR NTPS(O&M) and he/she has to report to CE/O&M/DR NTPS with immediate effect.
