In the reference 5th read above, the GoAP in order to minimize the hardship to the persons drawing Salaries/Wages/ Remuneration/ Honorarium from the Government/ Universities/Corporations/PSUs/State Autonomous Bodies/ Boards etc., ordered to pay the Salaries/Wages/ Remuneration/ Honorarium without deferment i.e. in full, from the month of May 2020 payable in the month of June, 2020 onwards duly effecting all the applicable types of recoveries/deductions. Separate orders shall also be issued regarding recoveries/deductions pertaining to the months of March, 2020 and April, 2020 & contribution to the CM Relief Fund by the employees and ordered all the Special Chief Secretaries/Principal Secretaries/Secretaries to Government, DTA/PAO/ DWA/Registrars of Universities/Heads of Corporations/PSUs/State Autonomous Bodies, all the Drawing and Disbursing Officers of HODs/Secretariat Heads to take suitable action in this regard.

The APGENCO hereby order for adopting the orders issued by the GoAP in the reference 5th read above for the employees of APGENCO for full payment of Salaries/Pensions/Wages/ Remuneration/ Honorarium from the month of May 2020 (payable in the month of June 2020) onwards duly effecting all the applicable types of recoveries/deductions. Separate orders shall also be issued regarding payment of Salaries/Wages/ Remuneration/ Honorarium already deferred and recoveries/deductions pertaining to the month of March & April 2020.
