AP Reorganisation Act 2014 – Bifurcation of Employees of Power Utilities between the states of Andhra Pradesh and Telangana – 536 employees finally allocated from TS Power Utilities to AP Power Utilities - Payment of salaries to the 254(252+2) finally allocated Employees to APGENCO (Out of 536 finally allocated from TS Power Utilities) from 01.07.2020 to the date of issue of posting orders – Instructions – Issued.

ORDER:

In pursuance of interim orders of Hon'ble Supreme Court of India dt: 08.04.2020 in MA No: 915/ 2018 in MA No: 60/ 2020 in CA No: 11435 of 2018 read with directions of Hon'ble Justice D.M. Dharmadhikari/ One-Man Committee from time to time, the AP Power Utilities paid the salaries/ pensions to the 655 employees relieved from TS Power Utilities from April 2020 to June 2020 on temporary basis through APPCC pending final bifurcation of the employees in view of the COVID-19 Pandemic prevailing in the country.

2. Hon'ble Justice D.M. Dharmadhikari/ One-Man Committee pleased to communicate the concluding report of bifurcation of the employees of power utilities between the states of Andhra Pradesh and Telangana in the reference 5th read above.

3. A compliance report has been submitted in the reference 6th read above, to Hon'ble One-Man Committee. In pursuance of the Direction-I of the concluding report dated 20.06.2020, out of 300 relieved employees from TSGENCO 46 employees were identified as completing the age of 58 years by December 2020 and the details of 46 employees have been submitted to Hon'ble One-Man Committee.

4. Since the bifurcation has been finalized, all the 254 employees finally allocated from TSGENCO to APGENCO have been issued posting orders on 09.07.2020, giving joining time to the employees as per norms.

5. It is hereby ordered that

- a) The 254(252+2) Employees shall be paid salary from 01.07.2020 to the date of issue of posting orders. Thereafter the payment of salary will be regulated as per the norms of joining time and duty.
- b) The pay and allowances for the 254(252+2) employees shall also be paid from 04.01.2020 to 31.03.2020 as per the directions of Justice D.M. Dharmadhikari One-Man Committee in the concluding report dated 20.06.2020.
- c) With reference to the Employees relieved from AP Power Utilities on 14.03.2020 and taken back to AP Power Utilities on 26.06.2020 their salaries and pensions shall be paid for the month of July 2020 as usual. With reference to their salaries from 15.03.2020 to 30.06.2020, the details of salaries/Pensions paid by TS Power Utilities shall be obtained and action for payment of balance salary/pension as per the norms applicable for AP Power Utilities.

The FA&CCA (Audit & Trust) & FA&CCA (Accounts & Resources) shall take necessary action to obtain the payment details made by the APPCC on temporary basis since April 2020 and account for to APGENCO and APPCC.
