ORDER:

In terms of the G.O. cited, the employees, as and when seek and apply for retirement on medical grounds, the concerned appointing authority shall refer the case to the Medical Board. The Medical Board shall give its report based on the detailed clinical examination and relevant investigations in a Government Hospital/Government Institutions like NIMS/SVIMS etc. and the appointing authority under whom the employee seeking medical invalidation is working, shall, after receipt of the Medical Boards recommendations refer the matter to a District Level Committee of officers for scrutiny and its recommendations. The committee is also competent to seek at its discretion personal presence of the employee seeking retirement on medical invalidation before considering the proposal.

2. After careful consideration, a committee is hereby constituted, comprising of the following members for scrutiny and approve the recommendations of the Medical Board Report to consider the Retirement of an employee on Medical Invalidation.
