ORDER:

In compliance of the directions contained in para 29 (I) of the Supplementary report dt.11-03-2020, read with clarificatory report dt.13.03.2020 of the Honourable One Man Committee, Sri./Smt. CH.BALAJI, DE-Elec, (Now:EE-Elec), (Emp ID No.1017189), had been allotted to **TSGENCO**, and relieved from the services of APGENCO with effect from **14.03.2020 AN** and he/she was ceased to be the employee of APGENCO in the reference 9<sup>th</sup> read above. 2) Thereafter, some stakeholders including TS Power Utilities have challenged the identification process, completed in terms of Supplementary Report dated 11.03.2020. All objections were duly considered and are put to quietus by Hon'ble Supreme Court vide order dated 08.04.2020, 01.05.2020, 03.06.2020 passed in MA filed by various parties and Concluding Report dated 20.06.2020 (10<sup>th</sup> cited) is submitted by the Honourable One Man Committee to Hon'ble Supreme Court.

3) As such, identification of 584 employees (revised as per directions of Hon'ble One Man Committee) to be allocated to T.S. Power Utilities is submitted to Hon'ble One Man Committee and same is approved and are part of Concluding Report dated 20.06.2020.

4) In addition to above, the further modifications as directed by Hon'ble One Man Committee in terms of Concluding Report dated 20.06.2020 is completed vide Compliance Report dated 26.06.2020 submitted to Hon'ble One Man Committee.

5) Thus in compliance with the Concluding Report dated 20.06.2020 of the Honourable One Man Committee and Compliance Report dated 26.06.2020 submitted to Honourable One Man Committee and further orders thereon, the orders issued in the reference 9<sup>th</sup> read above duly allotting Sri./Smt CH.BALAJI, DE-Elec, (Now:EE-Elec),(Emp ID No.1017189), to TSGENCO on final allotment are hereby rescinded and Sri./Smt CH.BALAJI, DE-Elec, (Now:EE-Elec),(Emp ID No.1017189 is now reallocated in APGENCO. He is directed to report to the MD/APGENCO/Vidyut Soudha/Vijayawada to get reposting orders.
