**ORDER:**

In memo 5<sup>th</sup> cited, the revised seniority in the cadre of AE(Elecl.) has been published duly revising the seniority pertaining to part of roster/approved list drawn for Direct Recruitment of AEs(Elecl.) of 2005 batch while fixing the seniority of Smt N Pushkarini, AE(Elecl.) & batch. Further, in memo 6<sup>th</sup> cited, the omission of the name of Smt G Leelavathi, AE(Elecl.) in the said revised seniority rectified and communicated.

2. Consequent to above revision of seniority in the cadre of AE(Elecl.), 3 (Three) approved lists dated:(i)06.10.2012, (ii)23.08.2013 & (iii)02.04.2014 drawn for promotion of AEs/AAs(Elecl.) as ADEs(Elecl.) were reviewed and revised in terms of Reg.8(ii)(c) of APSEB SRs Part-II as adopted by APGENCO, wherein the following ADEs(Elecl.) at Sl.No.1 to 8 have secured senior positions and the candidature of 3 Nos.AEs(Elecl.) were included for promotion as ADEs(Elecl.), as detailed below;

3. Further, upon inclusion of the above names in the approved lists noted against each, the above 3 Nos. AEs(Elecl.) (at Sl.No.9 to 11) are eligible for notional promotion as ADEs(Elecl.) along with 8 Nos. ADEs(Elecl.) (at Sl.No.1 to 8), with effect from the date of assumption of charge of their immediate juniors, **allowing monetary benefit only from the date of their actual joining on promotion as ADEs(Elecl.)**.

4. After careful consideration, under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, the following orders are hereby issued;

- a) Smt G Leelavathi, ADE(Elecl.) indicated at Sl.No.1 of the table in para-2 above, is promoted as ADE(Elecl.) **notionally** from the approved list dated:06.10.2012 on par with her immediate junior Sri D Madhava Rao, ADE(Elecl.) for the purpose of restoration of seniority in the cadre of ADE(Elecl.) as indicated in column(iv) of the Table at para-2 above, as the date of joining of Sri D Madhava Rao in the cadre of ADE(Elecl.) is later than the date of assumption of charge of Smt G Leelavathi on promotion as ADE(Elecl.).
- b) Smt Syed Althaf Unnissa, ADE(Elecl.) indicated at Sl.No.2 of the table in para-2 above, is promoted as ADE(Elecl.) **notionally** from the approved list dated:23.08.2013 w.e.f.20.04.13 i.e. the date of assumption of charge of her immediate junior Sri P Sampath Kumar, ADE(Elecl.) on promotion as ADE(Elecl.). However, she shall be allowed monetary benefit only from the date of her actual assumption of charge on promotion as ADE(Elecl.).
- c) The 6 Nos. ADEs(Elecl.) indicated at Sl.No.3 to 8 (Sl.No.3 to 5 & 7 are working with APGENCO and Sl.No.6 & 8 are working with TSGENCO) of the table in para-2 above, are promoted as ADEs(Elecl.) **notionally** on par with their immediate juniors in the same approved list dated:02.04.2014, for the purpose of restoration of seniority in the cadre of ADE(Elecl.), as indicated in column(iv) of the Table at para-2 above, as all have been promoted as ADEs (Elecl.) from the same approved list dated:02.04.2014 and joined in the promoted cadre of ADE(Elecl.) at their convenience. However, the monetary benefit already drawn from the date of their actual assumption of charge on promotion as ADEs(Elecl.) holds good.

d) The 3 Nos. AEs(Elecl.) indicated at SI.No.9 to 11 of the table in para-2 above, presently working with APGENCO, are promoted as ADEs(Elecl.) **notionally**, with effect from the dates noted against each under column (v), i.e. the date of assumption of charge of their immediate juniors on promotion as ADEs(Elecl.). However, they shall be allowed monetary benefit only from the date of their actual assumption of charge on promotion as ADEs(Elecl.) after issue of these orders

5. The promotions ordered in para-4 above are liable to be terminated at any time without notice and without assigning any reasons thereto. It is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers as on 01.11.1956.

6. The promotions ordered in respect of 3 Nos. AEs(Elecl.) mentioned at **SI.No.9 to 11** of table in para-2 above, are liable to be reviewed based on the outcome of;

- a) W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court and W.P.Nos.77074/93, 17126/93, 5221/93, 10199/92 pending in the High Court of A.P.
- b) W.P.No.19836/2000, W.P.No.3470/2008 and 14264/2009 pending before the Hon'ble High Court of A.P.
- c) Result of final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Reorganisation Act,2014, besides subject to the outcome of batch of writ petitions, No.16849/2015 and others pending before the Hon'ble High Court of Judicature at Hyderabad.

7. The Assistant Engineers (Elecl.) mentioned at **SI.No.9 to 11** of table in para-2 above, on temporary promotion as Assistant Divisional Engineers (Elecl.), are transferred and posted to the places noted against their names in the Annexure appended to this order.

8. The concerned controlling officers are requested to relieve the above AEs(Elecl.) immediately, by making local arrangements, to enable them to join at the place of posting ordered.

9. They are requested to assume charge on promotion as Assistant Divisional Engineers (Elecl.) at the place of posting within 10 days from the date of relief. No request for change of posting or sanction of leave will be entertained.
