ORDER :-

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri Shaik Mahaboob Basha, Junior Personnel Officer is promoted temporarily to act as Personnel Officer with effect from the date of assumption of charge.

- 02). The promotions ordered in para –1 above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
- 03). These orders are subject to the result of SLP.No.2360-91/83 filed by Retired Officers of the Board and pending in the Supreme Court of India.
- 04). The promotions ordered above are subject to result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of Writ Petition Nos.16849 and others, pending before the Hon'ble High Court and also the batch of SLP (Civil) No.20901 and other pending before the Hon'ble Supreme Court of India.
- 05). He should pass the APSEB Departmental Test for Administrative Officers Part-II (without books) within one of the first two examination after it is held failing which the promotions orders above are liable for termination without notice and without assigning any reasons thereto.
- 06). Sri Shaik Mahaboob Basha, Junior Personnel Officer O/o CE/O&M/RTPP on temporary promotion as Personnel Officer ordered in Para-1 above is transferred and posted as Personnel Officer, J-Section (Medical) under the control of A.S.(Medical & CCC)/VS/Hyd VICE Sri S. Kondala Rao, Personnel Officer is transferred.
- 07). On relief, Sri S. Kondala Rao, PO is transferred and posted as Personnel Officer/Regulations in the existing vacancy under the control of Joint Secretary, (Per)
- 08). They are requested to assume charge accordingly after obtaining proper relief from the present place of working.
- 09). The CE/O&M/RTPP is requested to relieve the above Junior Personnel Officer by making local arrangements within 15 days from the date of issue of this order. Otherwise the promotee shall be treated as deemed to have been relieved of his duties after expiry of the stipulated period.

10). He is requested to assume charge on promotion as Personnel Officer at the place of posting. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, their promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt:02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
