ORDER:

In terms of the orders issued vide G.O.1st cited, an Amendment to the Regulation.16(a)(1) of APSEB Service Regulations Part-I, as adopted by APGENCO, has been issued for enhancing the age of superannuation from 58 years to 60 years "with immediate effect" vide G.O.O.4rd cited. Further, an addendum to the said Regulation.16(a)(1) of APSEB Service Regulations Part-I has been issued vide G.O.O. 9th cited, substituting the words "with effect from 02.06.14" in place of "with immediate effect" in terms of the orders issued vide G.O.O. 8th cited read with G.O. 5th cited.

2. Further in the memo 10th cited, instructions have been issued to effect the re-induction of retired employees; wherein it is stipulated under para-5(a) that, he/she eligible for re-induction into service shall remit the pensionary benefits released to them viz. (a) Commuted value of pension (b) Retirement Gratuity (c) Encashment of Earned Leave along with interest @ SBI MCLR+2.5% per annum till date of remittance.

3. Accordingly, in memo 11th cited Sri G.Ratnaiah, SI (Retired on 30.06.16 A.N.) was issued notice to remit the pensionary benefits released to him along with interest thereon on or before 30.09.2017. In response to the notice, he has deposited an amount of Rs.57,87,984.40 (Rupees Fifty seven lakhs Eighty Seven Thousand Nine Hundred Eighty Four and Forty Paise Only) on 29.09.2017 and requested for issue of re-induction orders vide reference 12th cited.

4. In Memo No.CV&SO/SO/AS(Vig)/F.No.1064/D.No.17/2017, dt.27-01-2017 Sri G. Ratnaiah, Retd SI was appointed on contract basis for a period of one year w.e.f. 01-02-2017 to 31-01-2018 for attending the Security duties at Vidyut Soudha, Hyderabad. Further in memo 13th cited, the contract period of the retired SI was terminated from the date of issue of the said memo.

5. After careful consideration, Sri G.Ratnaiah, SI (Retired on 30.06.16 A.N.) is hereby re-inducted into service of APGENCO with effect from 11.10.17 and posted as Security Inspector under the control of Chief of Vigilance& Security/VS/VJA against the existing vacancy, subject to the conditions mentioned in memo 10th cited.

6. He is requested to assume charge accordingly within 7 days from the date of issue of these orders.
