ORDER :

In the reference 1st cited, orders were issued for conversion of Watchman, Canteen staff and other O&M employees who are drawing either Mazdoor equivalent pay scale or above Mazdoor but below JPA scale as Jr. Plant Attendants on completion of 5 years of service which counts for the increments, subject to the eligibility obtained after passing of Read and Write test and Job oriented tests conducted once in a year, i.e. in the month of “August of every year”.

2. After careful consideration of the proposals in the references 3-10 cited, wherein the reports of eligibility of the aforesaid O&M employees who have passed the Read and Write and Job Oriented Tests conducted **for the year 2013** have been submitted, approval is hereby accorded for conversion of following **posts** held by eligible Watchman, Canteen staff, unskilled and other O&M employees in various Generating Stations who have completed 5 years of service and who satisfy the conditions laid down in G.O.O. 1st cited **as Junior Plant Attendant post** as indicated below:
