ORDER:

In the reference second read above, orders were issued duly indicating the guidelines for relocation of offices and employees from Hyderabad to the new capital region and in and around Vijayawada and Guntur cities. The relocation of employees out of Hyderabad is, though technically not a transfer, shall for the purposes of financial entitlements, be treated as transfer. Finance Department shall issue orders to this effect.

- 2. Accordingly the following guidelines are issued:
 - a. The employees whose offices are relocated from Hyderabad to the new capital city of Amaravathi or to other places are entitled rates of Transfer TA as per the rates as fixed in the GO first read above.
 - b. The employees are eligible for journey time and joining time as per the Andhra Pradesh Fundamental Rules.

- c. These orders are applicable to the employees who shift their families to the new capital area and also to those who shifted their families in advance in view of start of academic year.
 - d. The employees prefer their detailed claims in the T.A. Bill form within six months of the actual shifting of their families or actual shifting of offices whichever is later.
 - e. All conditions in the A.P.C.S. (TA) Rules, 1996 in respect of TTA shall apply in this regard.
