After careful consideration, it is hereby ordered that the Fire Service Staff, i.e., Divisional Fire Officer, Assistant Divisional Fire Officer, Station Fire Officer, Leading Fireman, Fireman and Driver Operator etc., and the Fire Personnel of Government of A.P who are working on deputation in APGENCO shall be paid Uniform Allowance Rs.3,000/- instead of Rs.2,000/- each per annum and Uniform Maintenance Allowance Rs.150/- instead of Rs.100/- per month with effect from 15.12.2015 on par with the Security Staff.
