In the reference third read above, the GOAP while forwarding the copy of G.O.Ms.No. 299, Home (General-C) Department, dtd. 18.12.2007 have requested all the Departments of the Government to take personal interest for collection of “Flag Day Fund” as per the orders issued in the reference first read above. As seen from the G.O.Ms. No. 299, dtd. 18.12.2007, an amount of Rs. 20.00 and Rs. 50.00 from the salaries of the Non Gazeted employees and Gazetted Officers respectively is required to be deducted every year from their salary for the month of December payable in January effective from their salary from the month of December, 2007.

2. In the reference 2nd and 3rd read above, necessary orders were issued by APGENCO to all the Pay Drawing Officers inter-alia for recovery of an amount of Rs.20.00 and Rs. 50.00 per head from the salaries of Non Gazetted Officers and Gazetted officers respectively every year from the salary of each employee for the month of December payable in January effective from December, 2007 as their contribution towards “Flag Day Fund” to be utilized for the welfare schemes of ex-servicemen until further orders. Accordingly, contributions were deducted and remitted from the year 2008 onwards.

3. In the reference 4th read above, the Govt. of AP have issued orders to all the Heads of Departments and Heads of Offices, Drawing Officers to deduct an amount of Rs. 50/- and Rs. 100/- from the salaries of the Non Gazetted Officers and Gazetted Officers respectively every year from their salary of December payable in January of Succeeding year effective from December, 2015.

4. After careful consideration, the APGENCO hereby adopts the orders issued in the GO 4th cited and directs all the CEs/SEs, incharge of Generating Stations and FA&CCA(A&T) at Head Quarters, Vidyut Soudha Hyderabad to recover an amount of Rs. 50/- and Rs. 100/- per head from the salaries of Non Gazetted Officers and Gazetted officers, respectively, every year from the salary of each employee for the month of December payable in January effective from December, 2015 as their contribution towards "Flag Day Fund" to be utilized for the welfare schemes of ex-servicemen, until further orders and to remit the same to the Director Sainik Welfare, A.P., Hyderabad through online payment. The contributions made to the Armed Forces Flag Day Fund are exempted from Income Tax.
