ORDER :-

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri L. Hariprasad, Accounts Officer is promoted temporarily to act as SAO with effect from the date of assumption of charge.

- 02). The promotion ordered in para –1 above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
- 03). The promotions ordered in para –1 above are subject to result of S.L.P.Nos.2360 –91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.
- 04). The promotion ordered above are subject to result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of Writ Petition Nos.16849 and others, pending before the Hon'ble High Court.
- 05). After careful consideration, One vacant post of SAO under the control of CE/O&M/RTPP shall be temporarily diverted to the control of CGM (Adm, IS&ERP) and designated as SAO/ERP with immediate effect.
- 06). Sri L. Hariprasad, AO on temporary promotion as SAO ordered above is transferred and posted as SAO/B&R under the control of FA&CCA (R&A) VICE Sri S. Sreeranganayakulu, SAO is transferred.
- 07). On relief, Sri S. Sreeranganayakulu, SAO is transferred and posted as SAO/ERP under the control of CGM(Adm, IS & ERP) against the post diverted vide para-5 above.
- 08). The concerned controlling officers are requested to relieve the above Accounts Officer and Senior Accounts Officer by making local arrangements within 15 days from the date of issue of this order. Otherwise the promotee shall be treated as deemed to have been relieved of their duties after expiry of the stipulated period.

If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/2008, Dt:02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
